Music to be switched off until collection commences. Adjust sound levels. The music must be turned off at the end of the float round and not continue on the journey back to the main car park.
Refuelling generator	Fuel spillage Fuel explosion/fire	Reading Lions Members, Volunteers and the public	Low	High	The vehicle & trailer to be brought to a halt in a suitable location. Tow vehicle engine and generator to be switched off (this should switch off the lights and music). Check there are no naked lights in the vicinity. Refuelling to be carried out by the Driver with the assistance of the Team leader holding a torch to provide light if required. Check and clean up any spillages during and after refuelling.

If any fault it is to be ‘failed’ and taken out of use until fit for purpose. Visual inspection by team leader prior to every use.

					<p>Hand sanitiser and PPE will be made available for the Lions and Volunteers for use at their discretion should they wish to use.</p> <p>Each member will be given their own collection bucket for the duration of the evening. The bucket will be sealed and only to remain with the individual responsible.</p> <p>At the time of collection, the volunteer will hold the bucket in hand or the bucket will be put on the floor in a safe area on the footpath, and public will be encouraged to put money into the sealed bucket.</p> <p>This system will be deployed for every donation.</p>
